Notable M&A Activity

- Aquatech International, the Pennsylvania-based advanced water treatment company, sold 40% of its equity to Ecolab Inc., a global leader in water, hygiene and energy technologies and services, in a deal that involves an option to acquire the remainder of the business.
- **Evoqua Water Technologies** acquired **Neptune Benson**, a leader in commercial pool filtration from **Audax Group**. Audax built a portfolio of water filtration and disinfection products around Neptune Benson over the past few years.
- TestAmerica, an environmental testing laboratory company, was acquired by Shenzhen-listed consulting engineering firm JSTI Group. The merger positions JSTI to address the growing need for advanced water sampling by Chinese companies.
- H2O Midstream, LLC announced that it has received \$100 million in a round of funding in June 2016 from EIV Capital to build and operate midstream water assets in the O&G sector.
- The five largest private contract operators in the North American water and wastewater market (**Veolia, Severn Trent, American Water, CH2MHill** and **Suez**) generated combined revenues of \$1.98 billion last year a jump of 10.9% year-on-year.
- Badger Meter and Sensus USA are both exploring a sale by taking advantage of investor appetite for metering assets (\$5.1 billion sale of Elster to Honeywell end 2015). While Badger Meter is publiclytraded, Sensus has been held by private equity (Jordan Company and Goldman Sachs) for the past 13 years.
- Bilfinger Water Technologies was renamed Aqseptence Group following its recent acquisition by Chengdu Techcent.
- **Bolder Capital** and **JZ Capital Partners** are divesting **Triwater Holdings**. Triwater focuses on trenchless pipe rehab, industrial water treatment and residential filtration.
- **Dow Water & Process Solutions** broadened its capabilities in the wastewater space by injecting a single-digit million dollar sum for a minority equity stake in Irish MABR specialist **OxyMem**.
- AOSmith acquired AquaSana for \$87 million to establish a lead position in the growing residential water treatment e-commerce. AOSmith is globally recognized for its leading residential and commercial water heaters.






Extended M&A Summary Transaction Analysis



Summary

- Transaction valuations are relatively consistent, with annual medians ranging from 9 to 12x
 LTM EBITDA.
- Regression line shows "average" relationship between revenue multiple and EBITDA margin.
- Fairly consistent correlation between transaction valuation and LTM EBITDA margin.
- For example, a target with \$50 million in revenue and a 20% EBITDA margin on average would be valued at 2.2 x revenue or \$110 million.

Can you provide us a brief overview of Severn Trent?

Tell us about your background!



I've been in the water industry since 1991, having worked for a variety of water and wastewater firms. I've enjoyed roles in sales, marketing, business development, general management and operations, having worked for Dow Chemical, USFilter Corporation, Culligan International, Siemens Water Technologies, Western Reserve Water Systems and Severn Trent. Today, I am responsible for Severn Trent's entire field operations, which stretch across 22 states. I earned my BBA in Marketing from the University of Wisconsin and an MBA from the Kellogg Graduate School of Management at Northwestern University.



What markets do you serve?




We provide O & M services for municipal water and wastewater systems, targeting communities with population ranging from 20,000 to 200,000 people.

Waterside Chat: Industry One-on-One Interview



What are some of the biggest obstacles facing the municipal water market?





Another issue facing the municipal water and waste water treatment industry is the sheer cost of upgrading treatment infrastructure. While plants are expensive in and of themselves, there are even more latent problems looming in many communities' horizontal infrastructure. Given the miles of aging pipe in place, our industry is facing problems that have been kicked down the road for far too long.

The impact of both of these issues can be lessened by having third party support help municipalities, either to provide labor, capital or expertise. Sometimes, though, municipalities are reluctant to embrace an outsourced solution, preferring to deal with their issues inhouse for political or perceived cost saving reasons. This is a shame, though, as private operators are far easier to hold accountable than in-house operations, and many municipalities are missing an opportunity to have real expertise brought in to assist them.



What do you see as opportunities within water (and/or wastewater)?



Given a host of issues facing municipalities today—aging workers, outdated assets, unmet pension liabilities, mounting debt—some municipalities are seeking to monetize their water and wastewater assets through concession agreements. In exchange for a large upfront payment to the municipality entering the agreement, a concessionaire would assume responsibility for the operation and upgrade to any given city's assets. The concessionaire would then assume full utility management of the system, and would also manage the income provided by the ratepayers of the system. A concessionaire would get a long term operating contract, while a city would get quaranteed operation, along with a sizable upfront payment for them to use in retiring other liabilities.

We are also seeing increasing interest from industry to operate their water and wastewater assets, as they turn their attention to their core business.



How is technology impacting your business and the industry?



While the trend has been occurring for some time, automatic meter reading (AMR) is providing greater insight into non-revenue water (NRW) by detecting leaks and usage as well reducing the cost of meter reading. Along with AMR, we are also seeing an increased use of GIS (geographic information systems) to map system assets, document problem hotspots, and predict future failures. Computerized maintenance management systems (CMMS) and data management systems (DMS) help to manage asset lifecycle costs, and to assist in process control.



How have recent events at Flint, MI impacted your business?



Consumers are seeking peace-of-mind over the quality and safety of their drinking water now more than ever. As a result of the Flint, MI, lead problems, we are seeing more lead testing conducted by cities, schools, institutions, and individuals. In light of the indictments coming down in Flint, we are also seeing regulators act with more scrutiny of nearly every operator action or inaction on water systems. I expect to see more regulation imposed for public transparency, testing, and operational oversight before we are through. Nearly all drinking water actions are being looked at through a lens tinted by the Flint crisis.



How does Severn Trent view their organic vs acquisition growth initiatives?



Over the past few years we have focused on portfolio rationalization, and have sought to shed ourselves of underperforming contracts. We are opportunistically looking at bolt-on acquisitions that could leverage our existing business. We are also seeing increasing interest from industry to operate their water and wastewater assets, as they turn their attention to their core business.



Is there anything else that you would like to talk about or emphasize?



We are in the midst of a substantial business improvement initiative in our North American business. We have complemented our existing staff with several new and capable additions and we are set to transform our business for our customers. We aim to be the most trusted O & M provider in the market.

The McLean Group recently attended the **American Water Works Association** (AWWA) Annual Conference & Exposition (ACE16) held in Chicago, IL where a thousand exhibitors showcased a broad array of products and services primarily dedicated to the municipal drinking water treatment equipment and services market segment with secondary focus on water reuse, storm water and wastewater.

ACE16 follows the recent water contamination tragedy of Flint, MI. This is at a time when the industry is under intense scrutiny by regulators and consumers with regard to water safety. Companies that provide faster, more reliable testing and reporting to both utilities and consumers were quite busy during the show.

Technology advancements via Smart Technology are dramatically changing the landscape across most industries and water is no exception. Over the past few years, the ACE show has transformed from displays of the usual piping, valves, meters, etc. to dizzying displays of Smart Technology being applied across the board. No where is this more evident than in the use of an wearable digital glass product to leverage operational expertise by AdEdge Technologies, smart meters by Badger Meter, communication technologies and data analytics by Neptune and Sensus, and satellite technology for leak detection by Hydromax USA/ Utilis

There is continued discussion about the deterioration of our public infrastructure and its resulting impact on rising operating costs to address non-revenue water. Several expert panels discussed funding solutions for water infrastructure needs. Topics included an examination of current financial trends, including perspectives from credit agencies, an exploration of public–private partnerships, and a demonstration of how to successfully navigate funding for infrastructure projects.


